**DynTek Announces Second Quarter Results**  
*Company Realizes 37.7% Increase in Revenue for Second Fiscal Quarter*

**Irvine, CA – February 22, 2008 – DynTek, Inc. (DYNK.PK)**, a leading provider of professional technology services, today announced results for its second fiscal quarter ended December 31, 2007.

DynTek reported revenue of approximately \$25.5 million for the second quarter, up from \$18.5 million in the same period of the prior fiscal year, an increase of 37.7%. The company reported an EBITDA loss of \$1.0 million for the second fiscal quarter ended December 31, 2007, as compared to a gain of \$50,000 for the same period in the prior fiscal year. Excluding non-cash stock compensation expense charges, the adjusted EBITDA loss was approximately \$976,000 for the second quarter, as compared to positive adjusted EBITDA of \$198,000 for the same period in the prior fiscal year.

Gross profit increased to approximately \$4.1 million for the second quarter, as compared to \$3.7 million for the same period of the prior fiscal year. General and administrative expenses were approximately \$1.4 million during the second fiscal quarter, as compared to \$1.0 million during the same period in the prior fiscal year. General and administrative expenses decreased by \$247,000 from the preceding quarter ended September 30, 2007.

Net loss for the second quarter was \$3.2 million, as compared to a net loss of \$2.6 million for the same period of the prior fiscal year. Loss from continuing operations during the three months ended December 31, 2007 includes depreciation and amortization expense of \$404,000, non-cash stock based compensation expense of \$61,000, and interest expense of \$1.8 million (including non-cash interest of \$1.4 million).

“We continue to show strong top line growth which indicates our business is expanding, most notably in our anchor offices in California and New York,” said Casper Zublin, Jr., DynTek’s chief executive officer. “In the second quarter, our Canadian and TekConnect business units did not meet expectations, which affected our overall EBITDA number. Our Canadian office has a strong pipeline this quarter and our TekConnect business unit is posting more solid results as the result of a major restructuring.”

Zublin continued, “We continue to focus on cutting back G&A expenses and have successfully reduced expenses by \$247,000 from the first fiscal quarter. In addition, many of the changes and reductions we made will be realized in our third quarter results.”

**EBITDA**

The Company defines EBITDA as net income (loss) before interest, taxes, depreciation and amortization, and goodwill impairment charges. Other companies may calculate EBITDA differently. Although EBITDA is a widely used financial indicator of a company's ability to service debt, it is not a recognized measure for financial statement presentation under generally accepted accounting procedures (GAAP). EBITDA should not be considered in isolation or as superior or as an alternative to net income (loss) or to cash flows from operating activities as determined in accordance with GAAP. Nonetheless, the Company believes that EBITDA provides useful supplemental information for investors and others to measure operating performance, especially in situations where a company has significant non-cash operating expenses that are not indicative of core business operating results. EBITDA is widely used in the IT services industry to analyze comparable company performance, and management of the Company also uses EBITDA, in addition to GAAP information, as a measure of operating performance for assessing its business units as well as completed and potential acquisitions.
